### SEMINAR DETAILS:

**Morning session:** All operators of pleasure craft in British Columbia will soon be required to carry a Proof of Competency Operators Card. In this “All About Boats” seminar, new vessel licensing, user registration and competency requirements will be discussed, along with basic boating concepts such as differences in types of vessels (runabouts, sailboats, cruisers, multi’s, etc.), construction type, and cooking, heating and refrigeration systems.

**Afternoon session:** A more in-depth look at vessel construction and repair methods will be made, including the role of the surveyor in assessing the seaworthiness and condition of watercraft. In addition, a study of marine insurance coverages, warranties, and law (Marine Insurance Act, recent legal issues, and limitations of liability) will be undertaken, including the differences between personal and P&I liability and the implications of imported vessels.

Both sessions are fast-paced and aimed towards providing both a refresher and advanced knowledge to those involved in the insuring or adjusting of marine accounts. Informative, attention-grabbing videos, along with useful written materials, will be provided.
