Credits granted will be recognized as transfer credits only and will not be assigned a grade. This may affect qualification for an Honours CIP certificate and a student's chance at winning an academic prize.

Credits are available from the following programs:

Insurance Brokers Association of BC

With a completed CAIB designation only (full level 4), applicants are eligible for three (3) credits. CAIB graduates receive credit for C11, C130, and one (1) unspecified elective course.

There is no credit for individual CAIB courses.

→ **Transfer fee:** \$ 216.16 (*incl HST*) + Membership (*if not already a current member*)

BC Level 1 Licensing - General Insurance Essentials (GIE)

Credit for C11 is available for successful completion of the BC General Insurance Essential's (GIE) provincial examination. Applies to GIE course completed via BC 'Home Study Kit', or in class at Douglas College, Langara College, Career Gate Community College or Camosun College.

→ **Transfer fee:** \$ 104.16 (*incl HST*) + Membership (*if not already a current member*)

Life License Qualification Program (LLQP)

A credit for C66 is available for successful completion of the LLQP and provincial licensing examination.

→ **Transfer fee:** \$56.00 (*incl HST*) + Membership (*if not already a current member*)

Note: Effective August 1, 2009, courses taken through RMS, The School of Loss Control Technology (formerly the IAO School) will NOT be eligible for credit in the CIP Program.

To apply for credits:

1. Be a member of your local Institute (Insurance Institute of BC)*
2. Submit copies of the official result or evidence of success, including the actual mark and certificate.
3. Submit the applicable credit fee.

Credit Fees (*incl. HST*):

\$ 104.16 – C11

\$ 56.00 – All Other Courses (*per course*)

* **Membership Fees:** To apply for credits, applicant is required to be a member of the local Institute.

British Columbia Membership Fee = \$65.00 (*June 1, 2010 to May 31, 2011*)

Add \$ 65.00 to above credit fees if you are not a current member.
